USE OF CAMPSITE & OCCUPANCY INFORMATION

Camping is an outdoor recreational activity and the campground is a designated area where camping takes place. It is agreed by the parties that the intended use for the site is for seasonal recreational and vacation purposes only and as such the trailer cannot be used as a residence. The camper hereby undertakes and agrees that they will inform any family member and guest, visitor or other person attending the Camper's site as to the park rules and is responsible for them while at the park. The park is open for seasonal recreational use by the Seasonal Occupant (s) and his or her guests with services specified for a season commencing from the park opening date May 15th until October 15th in any year. This Camping Agreement must be approved by River Place Campground Ltd. no later than October 15, 2022 to reserve the subject site. See Section T*

This license is personal to the Seasonal Occupant(s) and Owner of River Place and is not transferrable.

The Seasonal Occupant(s) acknowledges and agrees that no business or sales of any kind shall be advertised or conducted on the premises. Renting or leasing out your trailer is strictly prohibited. See Section S*

Services and Fees:

The seasonal occupancy fee includes camping, daily visitors pass, overnight guests, winter storage, safe water, garbage and MPAC taxes.

- Hydro meters will be read and invoiced 3 times per season: June, August & October
- Meter Deposit Fee \$100.00
- Maintenance of Site applicable charges may apply See Section H, Rule #2*
- Winter Storage is \$150+HST per month See Section T, Rule #4*
- A NSF fee of \$75.00 + HST will apply to all returned payments.
- Park brokerage services MUST be used for sales within River Place Campground Ltd. and the selling price must be approved by
 management. Trailers older than 20 years cannot be sold on site or brought seasonally into River Place. Any camper that brings in their
 own trailer and is on a seasonal site cannot put their trailer up for sale unless it is sold off the lot. Transfer of ownership must be
 approved by Pike Lake.
